Public Hearing of Ordinance #013-2021 Joint Municipal Court

AN ORDINANCE OF THE TOWN OF HAMMONTON ESTABLISHING A SINGLE JOINT MUNICIPAL COURT WITH MULLICA TOWNSHIP; REAFFIRMING AND AMENDING JOINT MUNICIPAL COURT WITH THE BOROUGH OF FOLSOM, BUENA VISTA TOWNSHIP AND EGG HARBOR CITY; AND AMENDING CHAPTER 14, ARTICLE I OF THE GENERAL ORDINANCES OF THE TOWN OF HAMMONTON

WHEREAS, N.J.S.A. 2B:12-l(b) authorizes the formation of a single Joint Municipal Court provided that an Agreement is entered into by the Town of Hammonton and Mullica Township and provided that the Agreement is filed with the State of New Jersey Administrative Director of the Courts and the Assignment Judge of the Superior Court of New Jersey, Atlantic County; and

WHEREAS, the Town of Hammonton desires to enter into an Agreement to form a Joint Municipal Court with Mullica Township; and

WHEREAS, the Town of Hammonton, Borough of Folsom, Buena Vista Township and Egg Harbor City desire to enter into new Agreements for a Joint Municipal Court , which new Agreements shall replace the existing Joint Municipal Court Agreements set forth in existing Town of Hammonton Ordinance Section 41-1; and

WHEREAS, it is in the best interest of the Town of Hammonton to participate in a Joint Municipal Court with Mullica Township, Borough of Folsom, Buena Vista Township and Egg Harbor City.

NOW, THEREFORE, BE IT ORDAINED by Council of the Town of Hammonton, County of Atlantic, State of New Jersey, as follows;

1. Chapter 14, Article I, Section 1 is amended to read as follows:

§ 14-1. Establishment.

A Joint Municipal Court is established, pursuant to the provisions of N.J.S.A. 2B:12-l, et. seq., as amended and supplemented, consisting of the Town of Hammonton, Borough of Folsom, Egg Harbor City, Buena Vista Township and Mullica Township. The Joint Municipal Court with Folsom was created in accordance with an Agreement for a Joint Municipal Court for the Municipalities of the Town of Hammonton and the Borough of Folsom dated December 28, 2017, executed by the municipalities in January of 2018, and First Addendum to the Agreement dated September 19, 2019, fully executed on December 3, 2019 (the "Prior Folsom Agreements"), which Prior Folsom Agreements were replaced in their entirety with the Agreement for Joint Municipal Court for the Municipalities of the Town of Hammonton and the Borough of Folsom dated June 28, 2021, and

is subject to the terms thereof. The Joint Municipal Court with Egg Harbor City was created in accordance with an Agreement for Joint Municipal Court for the Municipalities of the Town of Hammonton and Egg Harbor City dated January 2, 2020, and executed in January of 2020 (the "Prior EHC Agreement"), which Prior EHC Agreement was replaced in its entirety with the Agreement for Joint Municipal Court for the Municipalities of the

Town of Hammonton and Egg Harbor City dated June 28, 2021, and is subject to the terms thereof. The Joint Municipal Court with Buena Vista Township was created in accordance with an Agreement for Joint Municipal Court for the Municipalities of the Town of Hammonton and Buena Vista Township dated August 24, 2020 and executed in August 2020 (the "Prior BVT Agreement"), which Prior BVT Agreement was replaced in its entirety with the Agreement for Joint Municipal Court for the Municipalities of the Town of Hammonton and Buena Vista Township dated June 28, 2021, and is subject to the terms thereof. Mullica Township shall join the Joint Municipal Court of the Town of Hammonton in accordance with an Agreement for a Joint Municipal Court for the Municipalities of the Town of Hammonton and Mullica Township dated June 28, 2021, and executed in August 2021.

2. The terms and conditions of the Agreement for a Joint Municipal Court for the Municipalities of the Town of Hammonton and Mullica Township dated June 28, 2021, are hereby approved. The Mayor and Clerk for the Town of Hammonton are hereby expressly authorized to execute and deliver the aforesaid Agreement on behalf of the Town.

3. The terms and conditions of the Agreement for a Joint Municipal Court for the Municipalities of the Town of Hammonton and the Borough of Folsom dated June 28, 2021, are hereby approved. The Mayor and Clerk for the Town of Hammonton are hereby expressly authorized to execute and deliver the aforesaid Agreement on behalf of the Town.

4. The terms and conditions of the Agreement for a Joint Municipal Court for the Municipalities of the Town of Hammonton and Buena Vista Township dated June 28, 2021, are hereby approved. The Mayor and Clerk for the Town of Hammonton are hereby expressly authorized to execute and deliver the aforesaid Agreement on behalf of the Town.

5. The terms and conditions of the Agreement for a Joint Municipal Court for the Municipalities of the Town of Hammonton and Egg Harbor City dated June 28, 2021, are hereby approved. The Mayor and Clerk for the Town of Hammonton are hereby expressly authorized to execute and deliver the aforesaid Agreement on behalf of the Town.

BE IT FURTHER ORDAINED, that if any section, paragraph, subsection, clause or provision of this Ordinance shall be adjudged by the Courts to be invalid, such adjudication shall apply only to the section, paragraph, subsection, clause or provision so adjudicated, and the remainder of the Ordinance shall be deemed valid and effective; and

BE IT FURTHER ORDAINED, that any Ordinances or parts thereof in conflict with the provisions of this Ordinance are repealed to the extent of such conflict; and

BE IT FURTHER ORDAINED, that this Ordinance shall take effect following adoption and approval in the time and manner prescribed by law.

ENGINEER REPORT

ACTION ITEMS:

1. Boyer Avenue Pump Station (ARH #11-50144):
Bids were received on Tuesday August 17, 2021. There were two bidders. Unfortunately, the bids have come in over the allocated budget. We will regroup with the PWTC to see if we can adjust the approach to the project. Due to funding available we recommend rejection of bids.

Action Requested:

1. Reject Bids for the Boyer Avenue Pump Station Project due to cost.

PUBLIC WORKS INFORMATION ITEMS:

Roadway & Transportation Projects

2. NJDOT Local Aid FY 2020 – 14th Street Roadway Improvements, Phase III (ARH #11-40058):
The Contractor returned to the site the week of 8/9 and addressed punch list items related to areas that needed restoration. Once required material testing is complete, we will be able to proceed with closeout of the project including funding requisition.
3. Hammonton Bike Path Connector (ARH #11-40052):
The construction contract is complete. We have provided a recommendation to approve the final quantities change order, accept the maintenance bond, and approve final payment. Once this is accepted and approved by Council we can begin the NJDOT closeout procedures.
4. Valley Avenue – Broadway to Central (ARH #11-30159):
Plans were sent to NJDOT, we have received a few comments that are being addressed. As discussed at the last Council meeting, we will look to set a bid date for later this year. The goal is to advertise this project and School House at the same time in an attempt to get an economy of scale. Spring 2022 is the current anticipated construction start.
5. School House Lane – 3rd Street to Rt. 54 (ARH #11-40060):
As discussed last meeting, this project is currently getting scheduled to be re-bid later this year. In an effort to obtain an economy of scale, this project will be bid with Valley Avenue. The intent is to bid later this year, with a work start anticipated in the Spring of 2022.
6. NJDOT – Local Aid Grants (ARH #11-40041): No status change.
The NJDOT accepted applications for FY2022 funding. As authorized ARH prepared the following applications for funding consideration:

Applications have been submitted and are pending NJDOT review.

Environmental Projects

7. K&K Linens Property / 224 Vine Street (ARH #11-01094.01):
As authorized ARH has prepared specifications for obtaining a contractor via quotes. Once received and a contract awarded, we will work with the contractor to have the building demolished. Separately we are preparing estimates to seek funding for the demolition activities.
8. Mazza Muffler Site / 104 S. Egg Harbor Road (ARH #11-01102):

The Town authorized the completion of a hazardous materials assessment, the field work associated with this effort was completed Tuesday, July 27th. Once the report of finding is complete, we can proceed forward with demolition specifications and obtaining a contractor.

9. Octagon Oil/Vine Street Parking Lot (ARH #11-01060): No Status Change
ARH is currently preparing a Remedial Action Permit application for ground water impacts. Once prepared we will coordinate with administration related to the content of the plan and for applicable application fees.
10. Celona Site Remediation - 130 Railroad Avenue (ARH #11-01054): No Status Change
As previously reported; three (3) permanent wells were installed and tested. Currently, we are taking periodic samples and tests. This is anticipated to extend into the first quarter of 2022. At the conclusion of this process, we will be able to assess if additional activity is needed.
11. Skinner Property / 317 N. Egg Harbor Road (ARH #11-01074.01):
The HDSRF grant application has been reviewed by NJDEP. The Town has received notice that this project will be funded. We will be preparing a proposal to for the Town's consideration to allow the project to proceed forward.

SEWER/WATER INFORMATION ITEMS:

12. 2021/2022 Water Capital Projects (ARH #21-0078):
As authorized, we have started the initial field work and base plan preparation. Our primary focus is to address Rt 54 to stay ahead of the NJDOT roadway project. Related to Rt. 54 we are finalizing plans in preparation of a submission to NJDEP. For reference the projects authorized include:

WHEREAS, the Town of Hammonton intends to submit in September 2021 an application to the New Jersey Department of Community Affairs, Small Cities Public Facilities Fund to develop Infrastructure Improvements in the community; and,

WHEREAS, the Small Cities Program requires, in certain instances, that professional services associated with the implementation of a Small Cities award be procured through a Competitive Contracting process;
