Resolution #97-2022- Determining Redevelopment Area

RESOLUTION DETERMINING THAT THE PREMISES IDENTIFIED ON THE MUNICIPAL TAX MAP AS BLOCK 2608, LOTS 1 AND 2 AND BLOCK 2902, LOT 12 CONSTITUTE A REDEVELOPMENT AREA AS SPECIFIED IN N.J.S.A. 40A:12A-6(b)(5)(b)

WHEREAS, Mayor and Council approved Resolution #104-2019 authorizing the Planning Board to conduct an investigation to determine, pursuant to N.J.S.A. 40A:12A-5 and 40A:12A-6, whether the area in question comprised of Block 2608, Lots 1 and 2 and Block 2902, Lot 12 is an area in need of redevelopment without the municipality's use of its eminent domain power; and

WHEREAS, the Planning Board at its meeting of June 1, 2022 conducted a hearing, the result of which was that the area in question be determined by the municipal governing body to be a redevelopment area; and

WHEREAS, following receipt of the Planning Board's recommendation, Mayor and Council are to determine whether to adopt or reject that recommendation; and

WHEREAS, Mayor and Council have given careful consideration to the Planning Board's recommendation, and the Report of Findings, Non-Condemnation Preliminary Redevelopment Investigation, Washington & 11TH Street Study Area, prepared by Stuart B. Wiser, P.P., A.I.C.P. of ARH Associates, and dated April 27, 2022.
