PWM REPORT

2023 Road Resurfacing Program

- APS has completed the gutter line work on Peach Street. They INTEND to complete the micro surfacing for the entire roadway surface this week as weather permits.
- The low bid received for the mill & pave program for the five listed roadways from Arawak Paving total price bid was \$468,700.
- The project bond ordinance becomes effective 10/02/2023.
- Frank will be reviewing possible additional funds as prior roadway projects are closed out.

Tennis/Pickle ball courts

The contractor has completed the work on the project. The final cost for the work completed to date with the approved change orders is \$523,800.11. The final payment (retainage) will be provided for consideration next month along with provisions of the project maintenance bond.

Atlantic County Recreation and Open Space Funding application

We are continuing the work with the County, the Town Solicitor, and the affected property owners as requested by Council related to the 3 properties involved for possible acquisition with County funding assistance. We will speak to the County about at least proceeding on two of the parcels.

Fourth Street Drainage and Outfall Pipe

The Town Municipal Utilities Department has completed the cleaning of the designated pipe sections with the exception of the last few sections where the water within the stream has backed up into those sections of pipe. We have contacted Mobile Dredging & Video Pipe to schedule their video inspection and provide a report of their findings and recommendations for repair if needed. They were onsite on Thursday, 9/21. We will wait for their video, report, and findings and keep Council informed.

Safe Routes to Schools (SRTS) GPI Final Design Scope

A letter was sent to NJDOT recommending approval consideration of GPI revised project scope for final project design. The NJDOT has reviewed the revised project scope and pricing and has provided some suggested modifications to GPI.

Lake Lowering Permit

The Town received the lake lowering permit from the State. The lowering will be started on November 1st and must be brought back to normal level by March 1st, 2024. A notice will be sent to residents on the lake requesting that they complete any cleaning of the lake bottom abutting their property during this time frame while the lake is lowered. The Town Municipal Utility Department will also inspect the boards within the dam structure and complete repairs/replacement of boards as needed during this time frame.

WHEREAS, the Partnership for a Drug-Free New Jersey has designated October 6, 2023, as Knock Out Opioid Abuse Day – an initiative with a multiple purposes: to raise awareness of the potential for dependency on prescribed pain medicine and its link to heroin and fentanyl use in our state; to reduce stigma of addiction and shine a light on the need for recovery support; and to communicate to physicians information on safer prescribing messages found in the Centers for Disease Control and Prevention guidelines for prescribing opioids, which include considering other therapies, setting realistic treatment goals with patients and discussing with patients the positives and negatives of opioids; and

WHEREAS, the State Senate and General Assembly jointly resolved that October 6 shall be permanently designated as Knock Out Opioid Abuse Day in New Jersey in order to raise awareness about the dangers of, and the link between, prescription opioid abuse and heroin addiction and to educate health care providers, community leaders, state lawmakers and members of the public about the opioid abuse epidemic and its effects throughout the State of New Jersey and across the country; and

WHEREAS, Join Together Atlantic County (JTAC) supports initiatives designed to raise awareness about opioid abuse in New Jersey and take steps to prevent addiction;
