### **Tree Removal Applications:**

- 1. Kimi McBrearty, 425 Valley Ave., 10 trees. Mr. Passarella was present on behalf of Mrs. McBrearty. The commissioners asked for further clarification from the homeowners regarding the plans for an addition. Motion to deny pending new application with plans for the addition attached. Motion: Cafiso; Second: Crowley. DENIED 4-0.
- 2. Atlantic City Electric, trimming at various locations. Councilman Oliva had a number of questions for ACE representative Matt Gerwien regarding the trimming practices of the company and resident concerns. Councilman Oliva noted that as trees are being trimmed or removed the debris is being left behind. Mr. Gerwien stated that before any work is done in front of a home, all homeowners are notified via a door hanger approximately 30 days prior to start of the work and later the homeowners sign an agreement stating they understand that the company does not remove all debris. They will chip up what they can and whatever is left will be cut into manageable size pieces and left for the homeowner to dispose of. If any homeowner does not agree to the policies ACE either does not remove the tree or they trim it to the best of their ability. Motion to approve: Cafiso; Second: Bethmann. Approved by acclamation.
