#### **PUBLIC HEARD FOR AGENDA ACTION ITEMS**

<u>Angela Donio 101 Tilton Street-</u> The bank building is very important building to the Downtown. It is a big part of this town and we should preserve our history and purchase the Building. Also spoke about the Atlanticare Building on the pike. That building was demolished and it was a historical building that should not have been destroyed, but the Town did not have any say in the matter.

<u>William Cappuccio Chestnut Street</u> – A month ago we were not going to get involved in the purchase of the Building. Why do we want to get involved in being landlords? The Town can try to used a program called Stressed Assets; can we look at this avenue? If we do not know the grant requirements, why not let the company's interested in the property but it?

<u>Mayor Stephen DiDonato</u>- Explained that the Town needs additional time to get the grant guidance to see what our options are in regards to purchasing this building. This vote is not a vote to purchase the building, but only additional time to determine if it is the correct decision to purchase. Mayor also commented that no one was misled. We knew about this issue all along.

<u>Solicitor Mike Malinsky</u>- Spoke about the assignment of the lease. The assessment had a hold harmless agreement included in it, the other party was not willing to agree to it. That is why we are at this point.

<u>Council woman Rodio</u>- Asked about going out to bid on the assignment. Also, asked if we could hold off on the vote tonight until we get the grant parameters.

<u>Councilman Furgione</u>- He also stated that the Town does not want to be a landlord either. If the property reverts back to Wells Fargo and they sell it the Town has no control.

<u>Councilman Gribbin</u>- Asked what restrictions are on the purchase now? Only restriction is that it can not be a bank or any type of financial institution.

<u>Councilman Rodio</u>- The Town has to do its due diligent and get all the information before saying no. The vote tonight is not to purchase the building it is only to give us more time to get information on the grant parameters to make an educated decision.

Councilman Marino- The \$142,500 that is needed to pass this ordinance where is that coming from?
