Resolution #150-2024- Hammonton Joint Municipal Court approval to execute the Addendum with the City of Northfield

First Addendum to the agreement for a Joint Municipal Court for the Municipalities Of the Town of Hammonton and the City of Northfield

THIS ADDENDUM made by and between the Town of Hammonton, a municipal corporation of the State of New Jersey, located in Atlantic County, New Jersey, with an address of 100 Central Avenue, Hammonton, New Jersey 08037 (hereinafter referred to as "Hammonton"); and the City of Northfield, a municipal corporation of the State of New Jersey, located in Atlantic County, New Jersey, with an address of 1600 Shore Road, Northfield, New Jersey 08225 (hereinafter referred to as "Northfield"); collectively known hereinafter as the "Municipalities", and each a "Municipality".

WHEREAS, Hammonton on May 22, 2023, adopted Ordinance #009-2023, establishing a Joint Municipal Court with Northfield; and

WHEREAS, Northfield on June 27, 2023, adopted Ordinance #008-2023, establishing a Joint Municipal Court with Hammonton; and

WHEREAS, it is anticipated that the Joint Municipal Court of Hammonton and Northfield will commence operations on January 1, 2025; and

WHEREAS, in accordance with paragraph 10(a) of the Agreement for a Joint Municipal Court the municipalities desire to amend the Agreement for a Joint Municipal Court in accordance with the First Addendum to reflect the January 1, 2025, commencement date.

NOW, THEREFORE, the Agreement for a Joint Municipal Court for the Municipalities of the Town of Hammonton and the City of Northfield is hereby amended as follows:

- 1. Paragraph 4(i), the commencement date of "January 1, 2024, is changed to "January 1, 2025".
- 2. Paragraph 4(i)(ii), the following change is made:
 - (i.e. If the Surplus Amount is \$10,000 from Revenue Period of 1/1/24 to 12/31/24 then 50% of the Surplus Amount would be paid by Hammonton to Northfield on or before 3/1/25) is changed to:
 - (i.e. If the Surplus Amount is \$10,000 from Revenue Period of 1/1/25 to 12/31/25 then 50% of the Surplus Amount would be paid by Hammonton to Northfield on or before 3/1/26) is changed to:
- 3. Paragraph 5(a), the commencement date of "January 1, 2024" is changed to "January 1, 2025".
- 4. Paragraph 5(a), the date pf "December 31, 2034" is changed to "December 31, 2035".
- 5. Paragraph 5(c), "January 1, 2024" is changed to "January 1, 2025".
- 6. Paragraph 6(b), "December 1, 2023 is changed to "December 1, 2024"

All other terms and conditions of the Agreement for a joint Municipal Court for the Municipalities of the Town of Hammonton and the City of Northfield not inconsistent here within shall remain in full force and effect.
